Today, we also feel these things as we say goodbye to one of the greatest heroes CASA by the Lakes and all of Calloway and Marshall county has ever had.


Judge Rob Mattingly is retiring from his position as the Family Court Judge for Calloway and Marshall county this November. CASA by the Lakes has had the honor of working

Superheroes aren't born-they're made.

All of our CASA volunteers go through extensive training so that they are able to serve the children of our community with the highest level of confidence. When someone signs up to be a CASA, they first go through 30 hours of training before being assigned a case (20 hours in class + 10 hours of home study). Then, they must additionally complete 12 hours of training every year. That's just one small part of what makes our volunteers superheroes!


