The following poem was written by a CASA volunteer:

I really didn't understand why I stood before a judge and why people I did not know talked about things that were difficult and painful to hear. I was embarrassed, intimidated, humiliated and afraid.

I didn't understand why I felt unloved, unwanted or unworthy. It was too painful to confront the reasons why I cried myself to sleep most nights. There seemed to be no one I could trust or tell. I wondered if anyone really did care.

There's a lot I didn't understand, and still I ponder a lot of "whys" and "what ifs". I now know that many of my questions may never be answered. Perhaps I'll never know. And maybe it's better this way.

But this I do know: I now go to bed each night with a happy heart. I am no longer afraid to close my eyes in sleep. I am safe and I am loved. And I dare to dream of a happy future.

The adult I shall become remains to be seen. You may never read my name in print, see my face on television, or read a book I've written. But you can be assured of this: You came into my life when I had no hope or dreams for anything more than what I was enduring at the time. You helped to change my future.

What I am today, whatever I shall become - you will always be a part of me--because you cared enough to get involved in my life! Thank you my CASA - my hero!
